We are very excited to have local musicians play at all of our 2017 markets! We greatly appreciate your talent and recognize that music helps set the tone for the market. If you and your band are interested in playing, please read the information below, fill out the application portion, and return to our office with CD or a link to where we can hear your music. We will get back to you concerning scheduling and confirm your availability. Thank you for your interest and we look forward to hearing you play!

Market Information

Boulder Saturday: First week of April through third week of November musicians play from **10 am-2 pm** in the food court. A tent and electricity are provided.

Boulder Wednesday: First week of May through first week of October musicians play from **4 pm-8 pm** in the food court. A tent and electricity are provided.

Longmont Saturday: First week of April through third week of November musicians play from **10 am-1 pm** under the pavilion. Electricity is provided however musicians may need to bring their own extension cords.

Union Station (Denver) Saturday : First week of June through the fourth week of October musicians play from **10 am-2 pm** in a TBD location on the Union Station plaza. A tent and electricity will be provided.

Disclaimer: Union Station bookings are limited to acoustic, 3 people, and no percussion due to space limitations.

Parking:

Boulder: Free Saturday parking is available at the RTD parking structure at 14th and Canyon. Parking in any of the 14th St. lots (behind the market) is reserved for customers and is prohibited to all vendors. Failure to comply with this policy will affect future involvement with BCFM.

Longmont: Free Saturday parking is available in the North parking lot of the Boulder County Fairgrounds. If space is available, you may park directly behind your designated booth space.

Union Station: Musicians are responsible for their own parking. There are a number of designated lots available in the vicinity of Union Station. These lot names and locations will be provided.

Scheduling: Our staff will do our best to schedule you on the requested dates. Please note that you will receive a confirmation email from your Market Coordinator 3-5 days before your scheduled date.

Conduct:

Music must play at an appropriate volume. Due to the close proximity to vendors there can occasionally be issues with volume that interferes with vendor-customer interactions. Volume must be immediately turned down if requested by any BCFM staff.

Cancellations/tardiness:

All cancellations must be done at least 24 hours in advance. Please be courteous and give us some time in order to schedule other entertainment. If you need to cancel, please contact the Boulder, Longmont or Denver Market Coordinator. If there is a chance of a late arrival, please call the Market Coordinator in order to ensure your time slot is not filled.
